




#### AIMS OF THE BIO4SAFE PROJECT

# Main parameters of European seaweed production

- Many of European countries produce seaweed:
  - 75% is produced by France & Norway
  - Total volume: **± 300.000 t WW** (1% of worldwide production)
  - Total revenue: ± \$ 55 mln.
- Average pricing: \$2 per kg DW
- 99% of the market depends on wild harvest


#### Opportunities and challenges

- European production is there, ingrediënts are interlinked and there are cultivatable species.
- Perception is more diffuse
  - Hesitant attitude of farmers in horti and agriculture
  - Low level awareness of seaweed biostimulant by e.g. sector organisations and end users
- At the same time a demand for sustainable ingrediënts in biostimulant products
